NOTICE OF 2012 ABHES COMMISSIONER ELECTIONS

Pursuant to Section 4.5.3 of the Bylaws of the Accrediting Bureau of Health Education Schools (ABHES), this notice from the Executive Director sets forth the time, date, place and procedures for election for Elected Seat 5.

In accordance with Section 4.5.3 of the Bylaws, the Commissioner Nominating Committee has considered nominations submitted in response to the published call for nominations for <u>Elected Seat 5</u> - <u>Educator in Specialty Area</u>. Based on this consideration, the Committee has nominated Ms. Nancy Last and Ms. Melody Montano for Elected Seat 5 to begin a three year term of office on July 1, 2012. The biographies and personal statements of each of these candidates are provided for your consideration at the end of this notice.

ABHES-accredited institutions and programs are encouraged to take part in this important election by completing the ballot electronically. **On-site elections will NOT be held so this is your only opportunity to vote.** The results of the election will be presented at the ABHES Membership Meeting on **Thursday**, **February 23, 2012, 4:15pm – 5:30pm**, at the **Encore Resort, Las Vegas, Nevada**, during the National Conference on Allied Health Education.

The elector ID and password will be emailed to the primary contact of each accredited institution/program from info@simplyvoting.com (On Behalf of ABHES.) Please add info@simplyvoting.com to your safe recipients list so that the email does not end up in your SPAM folder. If you are unsure who the primary contact of your institution/program check the ABHES Directory Institutions please of https://ams.abhes.org/ams/onlineDirectory/pages/directory.aspx. If you will not be casting the ballot for your institution/program, please forward the email to the designated person. ABHES will not be able to provide one person with all the Elector ID and passwords. It is up to the individuals listed as the primary contact to forward the information if necessary. We urge you to review the information on each candidate carefully and cast your vote timely. Once a ballot is cast, it cannot be changed.

Seat Available

The following seat is available for election in accordance with Section 4.5.1. of the ABHES Bylaws.

<u>Elected Seat 5</u> - Educator in Specialty Area. Must be currently and primarily employed in an academic position at a postsecondary institution accredited by an agency recognized by the Secretary of the U.S. Department of Education in a health-care related field for which ABHES is recognized as a programmatic accreditor by the Secretary of the U.S. Department of Education.

Eligibility to Vote

The following requirements as outlined in **Section 4.5.2. Eligibility to Vote.** Only institutions and programs accredited by ABHES are eligible to vote for elected Commissioners. The number of votes that may be cast is as follows:

- (a) Accredited Institutions. Each main campus or non-main campus receives two (2) votes.
- (b) **Accredited Programs.** Each address identified on record as having one or more accredited programs receives one (1) vote.

Procedures for Voting Electronically

- 1. Review carefully all information provided by the candidates, included in this correspondence, prior to casting your vote.
- 2. You will receive an email from info@simplyvoting.com containing your Elector ID and password along with a link on voting procedures and two voting links. One voting link will direct you straight to the ballot and the other you will need to enter your Elector ID and Password.
- 3. Log in to one of the two links provided in the email from <u>info@simplyvoting.com</u>.
- 4. If your log in was successful, you will be shown a menu listing all current ballots in which you are eligible to vote. If you have not yet voted, you may click on the ballot titled "2012 Commissioner Election" and an electronic ballot will appear.
- 5. Select the candidate in which you choose to vote. If you are an institutional member your vote will automatically be weighted as two (2) and if you are a programmatic member your vote will automatically be weighted as one (1).
- 6. Once you submit a ballot, the results are encrypted and stored in a database and your name is crossed out of an electronic list of voters. You will not be able to vote in this ballot again.

Results will remain confidential until all ballots are counted.

Procedures for Counting the Ballots

- 1. Upon receipt of a returned ballot, ABHES Legal Counsel will identify the school and ensure that the appropriate number of votes per institution or program is submitted.
- 2. Ballots will be counted by the Ballot Counting Committee during the Annual Membership Meeting on February 23, 2012, with the oversight of ABHES Legal Counsel. All votes electronic/mail votes must be received by no later than Thursday, February 16, 2012.

We anticipate announcing the outcome of the election during the reception following the Membership Meeting. The outcome of the election will also be posted on the ABHES website www.abhes.org following the conference.

STATEMENT OF INTENT

My name is Nancy Last and I have been involved in education for the past 22 years. My educational career began as a program developer for a Medical Assistant program. I was instrumental in developing the program through the accreditation application process with the Accrediting Commission for Career Schools and Colleges (ACCSC). As the program grew, additional programs including evening programs were added and I assisted with the original accreditation process and the re-evaluation of the institution's programs.

I have worked in private postsecondary education for the majority of my educational career, although I have worked in the public sector for several years developing a medical assistant program for an Applied Technology College (ATC). The ATC worked not only with adult populations but also in the high schools for students who wanted to begin their college experience in their senior year and were approved to do so by the State Board of Education. Moreover, I assisted with setting benchmarks that the Board of Education required for students to achieve in preparation for regional accreditation and student certification.

I have worked with a number of institutions developing many allied health programs which have included Medical Assisting, Pharmacy Technician, Medical Administrative Assistant, Dental Assisting, and Medical Billing and Coding programs.

Additionally, I have been an evaluator for the Accrediting Commission for Independent Colleges and Schools (ACICS) for the past 9 years and have been an evaluator for ABHES for the past 6 years. I have had the opportunity to serve on the Preliminary Review Committee for ABHES; a precursor and wonderful training opportunity to potential service on the Commission.

Since 2009 I have worked for Ameritech College in Draper, Utah, which is a privately owned college where, as Medical Assistant Program Director, for the last year and a half I had the opportunity to serve as program director of an on-line Medical Billing and Coding program.
